Subject Fees/Classes:

- Dancers 2 years Old-Kindergarten are required to take all 5 subjects (tap, ballet, baton, jazz, and gymnastics) for a monthly total of \$60.
- Dancers in 1st Grade-4th Grade are required to take the 5 core subjects (gymnastics, tap, ballet, baton, and jazz) and have the option also to take hip-hop. Each subject is \$12 per month. A student who takes all six subjects would have a monthly fee of \$72.
- Dancers 5th Grade and up have the option to choose their classes. Each subject is \$12 per month. A student who takes all six subjects would have a monthly fee of \$72. We require a 3-class minimum.

Costume Fee (Due October 1st)

- 2 Year Old Class: \$60 - 1 costumes
- Preschool (3 & 4 Year Olds): \$135 - 2 costumes
- Kindergarten and up: \$200 - 3 costumes
- Hip-Hop: \$65 - Additional costumes

The Pointed Toe Contract & Agreement:

Once you have registered, you are responsible for tuition payments from September – May. If you decide not to continue with us here at The Pointed Toe after beginning classes in September, you are still responsible for tuition payments from September – May. This includes the costume fee (due in October).

- We have a \$30 returned check fee.
- All payments are due the 1st of each month and are considered late after the 15th of every month.
- We have a \$10 late fee which is applied to all accounts not paid by the 15th of each month.

Waiver and Release Form/ Agreement to Contract

“Having been informed of the activities the registrant will be doing, I hereby consent to the registrant’s participation in dance class at The Pointed Toe. I voluntarily release and forever discharge The Pointed Toe, its owners, employees, and agents from any and all liability, claims, actions, or rights of action that are in any way related to the registrant’s participation in dance. I agree to indemnify and hold The Pointed Toe harmless from any and all costs or damages, including attorney fees, incurred in connection with the registrant’s participation in dance. I further agree not to sue, assert or otherwise maintain any claim or cause of action against The Pointed Toe arising from the registrant’s participation in dance.

In case of emergency, I understand every effort will be made to contact parents or guardians. However, if parents or guardians cannot be reached, I hereby give The Pointed Toe permission to act on my behalf in seeking and administering medical treatment if such treatment is deemed necessary for the registrant’s health, safety, and welfare. I release The Pointed Toe, its owners, employees, and agents from liability in acting on my behalf in this regard and rendering such medical treatment. I assume the risk and financial responsibility for any injury resulting from the registrant’s participation in dance.

I also understand that The Pointed Toe has my permission to use my or my dancer’s photograph publicly to promote The Pointed Toe. I understand the images may be used in print publications, online publications, presentations, websites, and social media. I also understand that no royalty, fee, or other compensation shall become payable to me because of such use.”
